

Client acknowledges that they are hiring Speaker, who is a social change activist.



Additional Terms and Conditions for Dr. Patch Adams

Technical Instructions: Client shall provide appropriate sound and lighting equipment for Speaker, and the following items:
1. One clip-on Lavalier microphone
2. One free-standing microphone
3. Table, water & pitcher
4. DVD player with screen large enough for entire audience to see
5. CD player with audio capabilities for entire audience to hear

Venue Requirements: Client agrees to furnish at its own expense all that is necessary for the proper



presentation of the Speaker, including:

- i. A suitable theater, hall or auditorium, well heated, lighted, clean and in good order
- ii. A sound system in good working order

Speaker Introduction: Speaker kindly requests that Client delivers a heartfelt introduction. Please refrain from simply using Speaker's biographical information, and instead create a unique introduction for the Speaker for the event.

Photography and Recording Speaker's Talk: Written and signed permission from The Joy Agency is required to record Speaker's talk. Photographs from the event are permitted to be shared. Video 15 seconds and shorter can be shared with permission from Kacie@TheJoyAgency.com. A copy of photographs and video must be sent to The Joy Agency within 7 business days of the event. No selling of video or photography is allowed.

Cancellation Policy: If this agreement is cancelled by Client, and Speaker is not rescheduled, the following list dictates the percent of the total fee that will be due.

0-90	days before engagement	100%
91-180	days before engagement	50%



In the event of cancellation of this Agreement by the Speaker or The Joy Agency due to illness, an unforeseen emergency, travel complications or Act of God, The Joy Agency, LLC nor Speaker will not have any liability for event expenses or losses related to the event other than Speaker's fees or deposits paid.

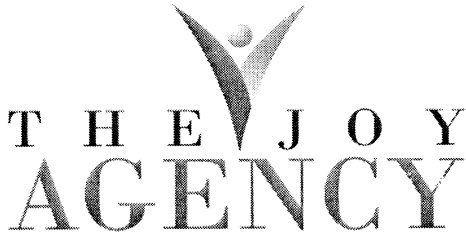

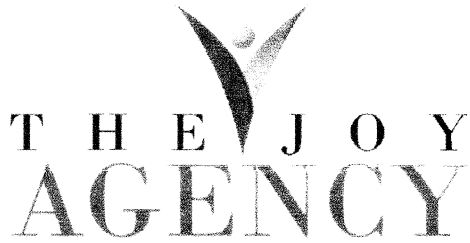


